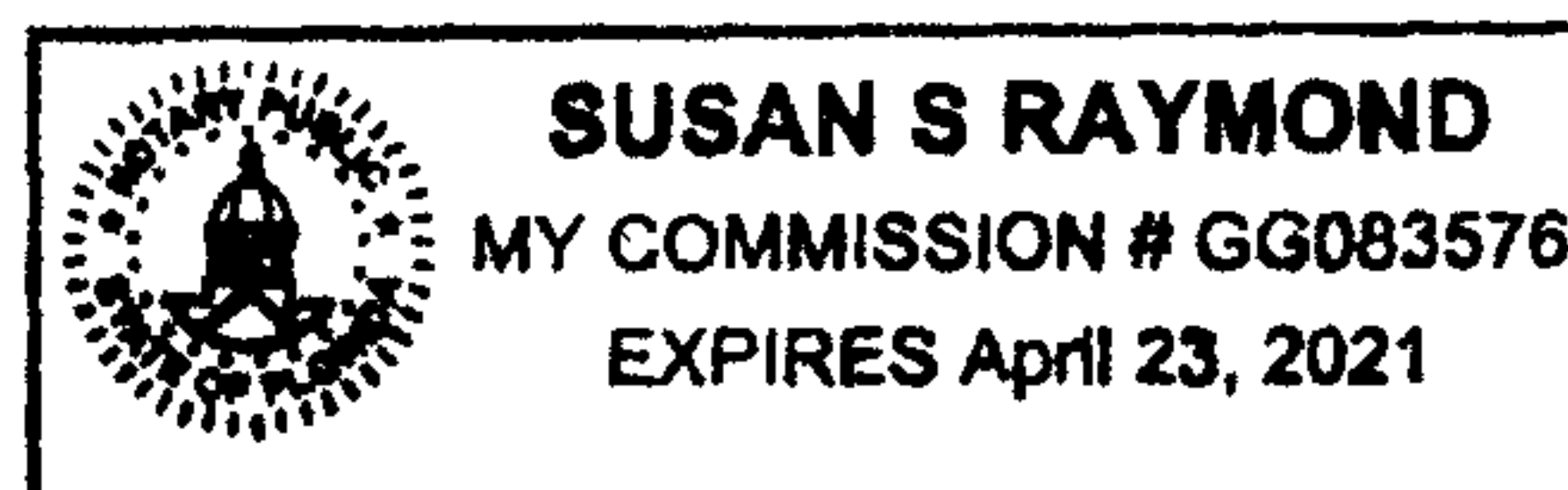

III. BOARD OF DIRECTORS

...

3. QUALIFICATION. Each director shall be a member of the Association, a spouse of a member, or a person exercising the rights of an owner who is not a natural person, ~~except that any director appointed by the Developer need not be a member of the Association.~~ All directors shall act without compensation unless otherwise provided by resolution of the membership of the Association.

4. ELECTION AND TERM. The term of each director shall be ~~one~~ two (2) years. All directors shall serve until their respective successors shall have been duly elected and qualified, or until their earlier resignation or removal. Board member elections shall be conducted pursuant to Section 718.112(2)(d)2 and Rule 61B-23.0021, FAC.

Commencing with the December 2019 Annual Meeting/Election, two (2) members will be elected for two (2) years and one (1) member for one (1) year. At the 2020 Annual Meeting/Election, the board member slot that was elected for a one (1) year term in 2019 will be the Board member slot up for election for a two (2) year term.

If necessary to re-implement staggering of director terms of office at any time, the Board of directors may temporarily assign a one (1) year term of office.
