**CERTIFICATE OF AMENDMENT
TO
DECLARATION OF DONCOMINIUM
OF
CAPRI WEST, A CONDOMINIUM**

The undersigned officers of Capri West Condominium Association, Inc., a not for profit Florida corporation organized and existing to operate and maintain Capri West, a Condominium, according to the Declaration of Condominium thereof as recorded in O.R. Book 1407, page 1427, et seq. as amended, of the Public Records of Sarasota County, Florida, hereby certify that the following amendment to the Declaration of Condominium was adopted with the approval of at least two-thirds (2/3rds) of the total membership of the Association at a meeting held on December 11, 2001. The undersigned further certify that the amendment was proposed and adopted in accordance with the condominium documentation, and applicable law.

1. Proposed Amendment to Article 7, section 1 of the Bylaws shall read as follows:

Section 1 CHECKS All checks or demands for money and notes of the corporation shall be signed by the President, Vice President, or Treasurer or by such officer or officers or such other person or persons as the Board of Directors may from time to time designate All checks, drafts, transfers or other withdrawals from the Association's accounts ~~in excess of One Thousand Dollars (\$1,000.00)~~ shall require the signature of at least two (2) members of the then serving Board of Directors for payment of construction contract draws in excess of One Thousand Dollars (\$1,000.00) and all final payments, of whatever amount, made to contractors, shall be approved by at least two (2) officers of the then serving Board of Directors
