WHEREAS, this Certificate of Amendment is being made as recordable evidence of this action by said Condominium Association imposing said restriction;

WHEREAS, the undersigned do hereby certify that the Amendment set forth herein was duly authorized by the regular members and the Board of Directors of the BAY VIEW EAST CONDOMINIUM ASSOCIATION, INC. at a special meeting called and that a majority of the regular members (80%) and the Directors present at said meeting voted in favor of adopting the Amendment hereinafter set forth;

NOW, THEREFORE, the above-described Declaration of Condominium is hereby amended by adding the following sub-paragraph to Paragraph 11 entitled: COVENANTS AND RESTRICTIONS CONCERNING THE USE OF UNITS, to-wit;

(Q) <u>RENTALS</u>: Any and all rentals of any unit of the BAY VIEW EAST CONDOMINIUMS, shall be for a time no less that <u>NINETY</u> (90) days, of any given year. This covers and includes all legal "AGREEMENT OF RENTAL" forms approved by the Association.
