

The following amendment to the Bylaws was submitted to the entire membership of the Association at its meeting called and held on the $24\frac{12}{2}$ day of $______, 2003$, and approved by affirmative vote of not less than a majority of the total voting interests in the condominium, as required by the Bylaws.

Article II, Membership, paragraph 3, Annual Meeting, is hereby amended to read as follows:
