TENANT PORTION OF THE RENTAL APPLICATION & INFORMATION DETAILS

Auburn Woods Owners Association requires all tenants to abide by its covenants, regulations, rules, and restrictions; regardless of their owner's or rental agency's leasing agreement. The Owner or their Rental agency can obtain a copy of the entire association covenants from Argus Management of Venice for a tenant's review. In addition, tenants are required to read the following summary categories of restrictions and then initial their understanding of these restrictions at the end of each category on the right side:

One passenger van or one pick-up truck for personal transportation purposes only, without advertising on the exterior, and which is not used for commercial purposes, may be parked on the driveway, but no lot may have more than one such vehicle regularly parked in the driveway. Overnight vehicle street parking is not permitted. Parking spaces located at the Clubhouse are reserved for mail pick up, clubhouse activities, and pool use. No long-term parking of owner or guest vehicles is permitted without prior permission. No vehicle maintenance, repair, painting or sanding is permitted. All garage doors shall be kept closed except when: 1. a vehicle or other article is being placed or removed from the garage; 2. owner is working in the garage, driveway or yard; 3. an opening from the floor of 12 inches or less is used for purposes of ventilation. Removal of any plantings from the wetland is not allowed. Dumping of any materials in the wetland, the retention pond, the detention pond(swale), or any common area is not allowed. Any animal which becomes a nuisance may be ordered to be removed from the property after a hearing before the Board. (i.e. feces collection, threatening actions, or excessive noise). Feeding of wildlife (e.g. birds, alligators, turtles, fish, and water fowl) is not permitted. | Miscellaneous | No illegal, noxious, or offensive activity is permitted. Nothing that may become a nuisance or source of embarrassment, discomfort, or annoyance to other residents is permitted. The retention pond shall not be utilized for swimming, bathing, boating or other recreational purposes. No containers or other items for garbage pick-up may be placed by the curb earlier than 5 pm on the day prior to its collection (Pickup). All trash, garbage, and refuse shall be stored in containers inside the garage prior to be placed by the curb for collection. All trash pickup must abide by City Ordinances for all trash or bulk trash pickup. Garbage containers must have provisions to secure their lids. The use of bungee cords to secure container lids is recommended to guard against scavenging animals. Plastic bags containing kitchen food scraps are not permitted to be placed by the curb for collection to prevent spillage caused by wind or scavenging animals.
